Pursuant to Article 145 (paragraph 2) of the Constitution of the Republic of Kosovo, taking into account articles 8, 9, 10 and 18 of the Law No. 06/L-113 on the Organization and Functioning of the State Administration and the Independent Agencies, (Official Gazette of the Republic of Kosovo /No.7/01 march 2019), taking into account article 8 paragraph 1 sub-paragraph 1.4, article 15 Appendix 11 of the Regulation (GRK) - No. 02/2021 on the Fields of the Administrative Responsibilities of the Office of Prime Minister and the Ministries (30.03.2021), Minister of the Ministry of Agriculture, Forestry and Rural Development issues the following:

DECISION

1. With this Decision shall be temporarily canceled the Administrative Instruction MAFRD No. 07/2013 on the Standard for the Flour Fortification, Control of Safety and Quality of Flour Fortification, date 02 August 2013.
2. The Administrative Instruction from point 1 of this decision is canceled until 31 July 2022.
3. Ministry of Agriculture, Forestry and Rural Development and other competent institutions are obliged to implement this decision.
4. The decision shall enter into force on the day of publication of the Official Gazette of the Republic of Kosovo.
