¹ Administrative Instruction (MAFRD) – No. 16/2024 on amending and supplementing the Administrative Instruction (MAFRD) No. 3/2015 on determining the form, content and manner of granting the licenses for the collection and industrial processing of tobacco and its products, signed by the Minister of Agriculture, Forestry and Rural Development with the date 09.08.2024

Pursuant to article 4 paragraph 3, Article 12 paragraph 3 of the Law No. 04/L – 04/L – 041 on Production, Collection and Trading of Tobacco (Official Gazette of the Republic of Kosovo No. 26/25 November 2015), taking into account article 12 paragraph 1 sub paragraph 1.3 of the Law No. 06/L – 113 on the Organization of State Administration and Independent Agencies (Official Gazette, No. 07, date 01 March 2019), in accordance with article 9 paragraph 2 of the Regulation (GRK) – No. 17/2024 on Rules of Procedure of the Government of the Republic of Kosovo (Official Gazette 21.06.2024), Minister of the Ministry of Agriculture, Forestry and Rural Development,

Issues:

ADMINISTRATIVE INSTRUCTION (MAFRD) – NO. 16/2024 ON AMENDING AND SUPPLEMENTING ADMINISTRATIVE INSTRUCTION (MAFRD)-No. 3/2015 ON DETERMINING THE FORM, CONTENT AND MANNER OF GRANTING THE LICENSE FOR THE COLLECTION AND INDUSTRIAL PROCESSING OF TOBACCO AND ITS PRODUCTS

GENERAL PROVISIONS

Article 1

Purpose

This Administrative Instruction aims to amend and supplement Administrative Instruction (MAFRD) No. 3/2015 on determining the form, content and manner of granting the license for the collection and industrial processing of tobacco and its products in order to create the legal basis for the implementation by sub – legal acts by the Food and Veterinary Agency that determine the granting of permits and licenses for the collection and industrial processing of tobacco and its products.

Article 2

In article 4 of the basic Administrative Instruction, the sentence “Department of Agricultural Policies and Trade” is replaced by the sentence “Food and Veterinary Agency”.

Article 3

Article 5 sub – paragraphs 1.1, 1.2, 1.3 and 1.4 of the basic Administrative Instruction, are deleted and added a new paragraph as follows:

2. In electronic system the license electronic form is created which contains the elements according to the paragraph 1 of this article and it has the same value like physical certificate which may be downloaded by the person at any time through this system.

Article 4

Article 6 sub – paragraphs 1.1, 1.2, 1.3. and 1.4 of the basic Administrative Instruction is deleted, and added a new paragraph as follow:

2. In electronic system the license electronic form is created which contains the elements according to the paragraph 6 of the basic Administrative Instruction and it has the same value like physical certificate which may be downloaded by the person at any time through this system.

Article 5

Article 9 paragraph 1 of the basic Administrative Instruction, the word “Secretary General” is replaced by the word “Executive Director”, and paragraph 2 is deleted and reformulated by the following text:

2. Commission is consisted of three (3) members by the Food and Veterinary Agency.

Article 6

Article 10 paragraph 2 of the basic Administrative Instruction, the word “Secretary General” is replaced by the sentence “Executive Director of the Food and Veterinary Agency”, and paragraph 2 is deleted and reformulated by the following text:

Article 7

Article 11 paragraph 1 and 2 of the basic Administrative Instruction, the sentence “Department of Agricultural Policies and Trades” is replaced by the sentence “Food and Veterinary Agency”, and in paragraph 3 of this article the word “Secretary General” is replaced by the word “Executive Director”.

Article 8

Article 12 of the basic Administrative Instruction, is deleted.

Article 9

Article 13 of the basic Administrative Instruction, is deleted.

Article 10

In article 14 of the basic Administrative Instruction, the sentence “Department of Agricultural Policies and Trade” is replaced by the sentence “Food and Veterinary Agency”.

Article 11

Entry into force

This Administrative Instruction shall enter into force seven (7) days after the Publication in the Official Gazette of the Republic of Kosovo.
