Pursuant to article 34, Article 35 paragraph 6 and 10 of the Law No. 03/L-042 on Plant Protection Products (Official Gazette of the Republic of Kosovo No. 44/22.12.2008), taking into account article 12 paragraph 1 sub paragraph 1.3 of the Law No. 06/L – 113 on the Organization of State Administration and Independent Agencies (Official Gazette, No. 07, date 01 March 2019), in accordance with article 9 paragraph 2 of the Regulation (GRK) – No. 17/2024 on Rules of Procedure of the Government of the Republic of Kosovo (Official Gazette 21.06.2024), Minister of the Ministry of Agriculture, Forestry and Rural Development,

**GENERAL PROVISIONS**

**Article 1  
Purpose**

This Administrative Instruction aims to amend and supplement the Administrative Instruction (MAFRD) No. 05/2017 on the repackaging of plant protection products in order to create a legal base for the implementation of sub – legal acts by the Food and Veterinary Agency which specify the permit – authorization for certification of plant protection products.

**Article 2**

In article 3, sub – paragraph 1.7 of the basic Administrative Instruction, the sentence “Department means the Department of Agricultural Policies and Trade” is replaced by the sentence “Agency means the Food and Veterinary Agency”.

**Article 3**

Article 4, paragraph 2 of the basic Administrative Instruction at the end of the paragraph after the point, the following text is added: “The request is submitted in accordance with the rules defined in the relevant Law on the General Administrative Procedure (hereinafter LGAP)”.

Article 4 paragraph 4 of the basic Administrative Instruction, at the end of the paragraph after the point the following text is added: “Completion and submission of the application form can also be done through the electronic system”.

**Article 4**

1. Article 8 paragraph 1, sub – paragraph 1.1. of the Basic Administration is reformulated as follows:

“1.1. Be registered as a business”.

2. Article 8, paragraph 1, under paragraph 1.3. of the basic Administrative Instruction is reformulated as follows:

“1.3. Evidence or information on general analyzes of PPPs issued by an accredited laboratory”;

3. Article 8, paragraph 1, sub - paragraph 1.7 of the basic Administrative Instruction is reformualted as follows:

“1.7. The information that proves the phytosanitary inspection has been carried out”.

4. Article 8 paragraph 1 sub - paragraph 1.10 of the basic Administrative Instruction is reformulated as follows:

“1.10. Information that you have an important permit”.

#### **Article 5**

Article 12 of the basic Administrative Instruction, is deleted.

#### **Article 6**

In article 13 of the basic Administrative Instruction, the word “Department of Agricultural Policies and Trade” is replaced by the word “Food and Veterinary Agency”.

#### **Article 7**

Article 14 of the basic Administrative Instruction, is deleted.

#### **Article 8**

Article 15 of the basic Administrative Instruction, is deleted.

#### **Article 9**

Article 16 of the Administrative Instruction, is entirely deleted and reformulated as follows.

#### **Article 16**

#### **Suspension and cancellation of permit**

The permit may be suspended or cancelled in accordance with the rules set forth in the relevant law for the system of permits and licesnes.

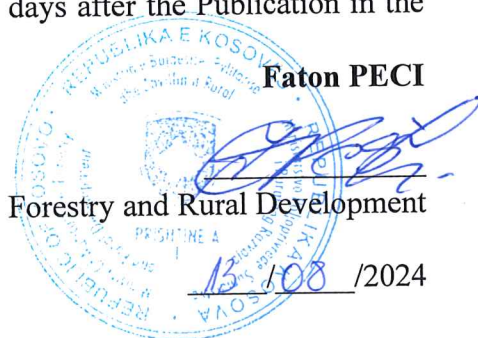
#### **Article 10**
