Pursuant to Article 145 (paragraph 2) of the Constitution of the Republic of Kosovo, taking into account articles 8, 9, 10 and 11 of the Law No. 06/L – 113 on the Organization and Functioning of State Administration of the Independent Agencies, (Official Gazette, No. 7/01 March 2019), based on Article 8 (paragraph 1.4) article 15, Annex 11 of the Regulation (GRK) – No. 02/2021 on the Areas of the Administrative Responsibilities of the Prime Minister's Office and the Ministries (30.03.2021), and Article 20 (paragraphs 1,4 and 5) of the Law No. 03/L - 042 of the Plant Protection Products (Official Gazette No. 44, date 22.12.2008) as well as based on recommendation of the Commission on assessment and authorization of the Plant Protection Products, with Ref. 04-382/23, of the date 31.07.2023, Minister of the Ministry of Agriculture, Forestry and Rural Development, issues the following:

DECISION

On the Inclusion in the register and permitting the authorization to use plant protection product

1. The import, placement in the market and the authorization to use plant protection product – Decis Expert of producer "Bayer AG", Germany from its representative "Agromarket KS" Prishtinë shall be permitted.

2. TYPE OF PRODUCT:

Insecticides

3. CONTENT OF ACTIVE SUBSTANCE: Delthametrin.......100g/l

4. USE:

Decis Expert is an insecticide with fast contact and digestive action, with a wide spectrum of action intended for the control of harmful insects in wheat and corn crop. Decis Expert used in these crops:

1) Wheat, for the control of the Cereal leaf beetle (Lema melanopus), the quantity of use 0.0751/ha (0.75ml/100m²) and the quantity of water spent from 200-400l/ha(2-4l/m²) after the appearance of first damages and new stages of insect's larvae;

- 2) Corn, for the control of the corn borer (Ostrinia nubilalis), the quantity of use 0,075-0,1251/ha (0,75-1,25ml/100 m²) and the quantity of water spent from 200-400l/ha treating 10 days after the maximum flying of butterflies or with an appearance of new stages of larva of insects.
- 3) Alfalfa, for the control of the alfalfa leaf eating (Phytodecta fornicata) the quantity of use 0,05-0,075l/ha, treatment after appearance of the grown insect with the quantity of water spent from 200-4mm l/ha
- 4) Colza, for the control of blossom beetle (Meligethes aeneus) in the quantity of 0,075l/ha, the treatment at the time of appearance of the adult insect when the main flower is visible but still closed until the opening of the first flowers (50-60 BBCH rate) quantity of water spent 200-400l/ha.
- 5) Sunflower, for the fight of plant's aphids (Aphididae) in the quantity of application 0,075l/ha water consumption 200-400l/ha, more treatment after appearance. The maximum number of treatments is once.
- 6) Cherry, for the fight against cherry fruit fly (Rhagoletis cerasi) in the quantity of application 0,175l/ha and water consumption 1000l/ha. Treatments are carried out at the time of mass flight, before the color change of the fruit (phenophase BBCH 80), by spraying or in the form of dew. The maximum number of treatments is one.

5. PACKING QUANTITY FOR IMPORT:

100ml;500ml,1L,5L

6.REMARK:

It is not allowed to be applied during the flight of the bees.

7. KARENCA:

The time between the las treatment and harvest, respectively harvest: wheat 35 days, corn 30 days. alfalfa 14, colza 42 days, sunflower 60 days, cherries 7 days.



8. PROPOSAL OF CLASSIFICATION:

GHS09 - warning (cat 1)-environmental hazard



GHS07- irritant (cat 2 or 3)



GHS08- harmful to health



GHS03- Oxidising



GHS05- warning for hazard – corrosive

- 9. PLACE OF SELLING: In the whole territory of the Republic of Kosovo.
- 10. The plant protection product authorized by point 1 of this decision is allowed to be imported into the Republic of Kosovo, until the deadline as defined in the registration certificate, based on the EU Pesticides/Active Substances Database, while circulation and its use is allowed according to article 26 paragraph 3 of Law No. 03/L-042 of Plant Protection Products.

11. This decision shall enter into force on the day of signature.
