Pursuant to Article 145 (paragraph 2) of the Constitution of the Republic of Kosovo, taking into account articles 8, 9, 10 and 11 of the Law No. 06/L – 113 on the Organization and Functioning of State Administration of the Independent Agencies, (Official Gazette, No. 7/01 March 2019), based on Article 8 (paragraph 1.4) article 15, Annex 11 of the Regulation (GRK) – No. 02/2021 on the Areas of the Administrative Responsibilities of the Prime Minister's Office and the Ministries (30.03.2021), and Article 20 (paragraphs 1,4 and 5) of the Law No. 03/L – 042 of the Plant Protection Products (Official Gazette No. 44, date 22.12.2008) as well as based on recommendation of the Commission on assessment and authorization of the Plant Protection Products, with Ref. 04-382/23, of the date 31.07.2023, Minister of the Ministry of Agriculture, Forestry and Rural Development, issues the following:

DECISION

On the Inclusion in the register and permitting the authorization to use plant protection product

1. The import, placement in the market and the authorization to use plant protection product – **Roundup Pro** of producer “**Bayer AG**”, **Germany** from its representative “**Agrohelf- SA**” **SH.P.K, Rahovec**. shall be permitted.

2. **TYPE OF PRODUCT:** Herbicide

3. **CONTENT OF ACTIVE SUBSTANCE:** Glyphosate.....360g/l

4. **USE:**

ROUNDUP PRO is a herbicide that is used after germination of weeds, with total action, controlling broadleaf and narrowleaf weeds in the active growth phase. After being taken from the leaves, it circulates with plant juices in all parts, especially underground ones. It leaves no residue in the soil, so soils treated with Roundup Pro can be planted a few days after treatment with all types of crops. Roundup Pro can be used before planting vegetables, beets, wheat and other crops, rice, meadows, nurseries, orchards, etc. Displacement of seedlings and sowing of seeds should be done at least 48 hours after treatment.

It is used to fight weeds in citrus, seed and nuclear trees, olives, vineyards, rose gardens, etc. Not recommended in orchards and new vineyards.

In addition to agriculture, it has also found use in weed control on sidewalks and roadsides, between railroad tracks, and other environments where the presence of weeds is a concern.

Usage dose:

6-12 liters/ha, using 400-600 liters of water, depending on weed development. Against annual weeds such as: *Rumex hyumenosepalus*, *Cyperus spp.*, *Cirsium arvense*, *Sorghum halepense*, with 6 liters/ha. Against moderately resistant weeds such as: *Artemisia spp.*, with 8 liters/ha. Against resistant weeds the dose can be increased: for grasses 10 liters/ha, for *Convolvulus spp.* 12 liters/ha.

5. PACKING QUANTITY FOR IMPORT:

0.5L and 1L(38mm), 1L(63mm), 2L(38mm), 5L and 10L(63mm), 15L and 20L(61mm).

6. REMARK:

Avoid contact of spray droplets with other agricultural crops. Do not spray on windy days. Do not treat weeds that suffer from various stresses such as drought, cold, etc.

It does not mix with other products with an alkaline or acidic reaction.

It is used exclusively at the time and for the purposes provided for in this label. Any other use would be risky. The user is responsible for damages that may be caused by use other than the recommendations on this label,

7. KARENCA:

It does not get applied.



8. PROPOSAL OF CLASSIFICATION:

GHS07- irritant (cat 2 or 3)

9. PLACE OF SELLING: In the whole territory of the Republic of Kosovo.

10. The plant protection product authorized by point 1 of this decision is allowed to be imported into the Republic of Kosovo, until the deadline as defined in the registration certificate, based on the EU Pesticides/Active Substances Database, while circulation and its use is allowed according to article 26 paragraph 3 of Law No. 03/L-042 of Plant Protection Products.

11. This decision shall enter into force on the day of signature.
