Pursuant to Article 145 (paragraph 2) of the Constitution of the Republic of Kosovo, taking into account articles 8, 9, 10 and 11 of the Law No. 06/L – 113 on the Organization and Functioning of State Administration of the Independent Agencies, (Official Gazette, No. 7/01 March 2019), based on Article 8 (paragraph 1.4) article 15, Annex 11 of the Regulation (GRK) – No. 02/2021 on the Areas of the Administrative Responsibilities of the Prime Minister’s Office and the Ministries (30.03.2021), and Article 20 (paragraphs 1,4 and 5) of the Law No. 03/L – 042 of the Plant Protection Products (Official Gazette No. 44, date 22.12.2008) as well as based on recommendation of the Commission on assessment and authorization of the Plant Protection Products, with Ref. 04-382/23, of the date 31.07.2023, Minister of the Ministry of Agriculture, Forestry and Rural Development, issues the following:

DECISION

On the Inclusion in the register and permitting the authorization to use plant protection product

1. The import, placement in the market and the authorization to use plant protection product – **Valis F** of producer “**Belchim Crop Protection NV/SA**”, **Belgium** from its representative “**Agronomi Group**” **SH.P.K, Suhareka** shall be permitted.

2. TYPE OF PRODUCT: Fungicide

3. CONTENT OF ACTIVE SUBSTANCE: Valifenalate.....60+- 6g/kg
Folpet.....480+-24g/kg

4. USE

Valis F is a contact -systemic fungicide applied to grape vines (wine and table varieties) for the control of the blight (*Plasmopara viticola*) in quantity of 2 kg/ha, quantity of water 100-1000 L/ha. Applied in varieties from the 5 – leaf stage of development to the end of flowering (BBCH 15-83), and to table varieties from the 5 – leaf stage of development to the end of flowering (BBCH 15-69). A maximum of 2 applications during a growing season are allowed, with an interval between applications of at least 10 days.

5. PACKING QUANTITY FOR IMPORT:

1kg, 5kg, 10kg.

6. REMARK:

The treatment should not be carried out in windy weather. When used on table grape varieties, the last application should be made no later than the end of flowering (BBCH 69). Aerial application is not permitted. When using Valis F, water regulations must be observed in order to protect water. Valis F should not be used in karst areas and light, skeletal sand and all other soils where the risk of passing into groundwater increases.

If other regulations do not provide for a greater safety distance, the safety distance from surface water must be observed in order to protect beneficial and non – target organisms – measured from the edge of the coast, which for approved applications is to at least 20m with a protective vegetative layer of 20m.

Agent and spray residues should not enter surface water, wastewater, yards and permanent drains. Pesticides application machinery and sprayers should be washed in the field, in places where the agent cannot reach surface water and where there is no danger to people and animals.

8. PROPOSAL OF CLASSIFICATION:



GHS07- irritant (cat 2 or 3)



GHS05- warning for hazard – corrosive



GHS08- harmful to health



GHS09- warning (cat 1)-environmental hazard

9. PLACE OF SELLING: In the whole territory of the Republic of Kosovo.

10. The plant protection product authorized by point 1 of this decision is allowed to be imported into the Republic of Kosovo, until the deadline as defined in the registration certificate, based on the EU Pesticides/Active Substances Database, while circulation and its use is allowed according to article 26 paragraph 3 of Law No. 03/L-042 of Plant Protection Products.

11. This decision shall enter into force on the day of signature.
