Based on UNMIK Regulation No. 2001/19 dated on 13 September 2001 on the Provisional Institution of Self Government in Kosovo article 1.3 point (d) and Regulation No. 2005/15 on the amendment of the UNMIK Regulation No. 2001/19 on the Executive Branch of Provisional Institution of Self Government in Kosovo UNMIK/REG/2005/15 dated on 16 March 2005, articles 13 and 24 related to the articles 18,19,20,22 and 23 on the Fishing and Aquaculture Law UNMIK/REG/ 2006/58 dated on 20 December 2006 Ministry of Agriculture, Forestry and Rural Development

Approves the following:

ADMINISTRATIVE INSTRUCTION MA - NO. 24/2007 ON THE SPORTIVE- RECREATIVE FISHING MEANS AND EQUIPPMENTS ON THE SPORTIVE – RECREATIVE

Article 1

Purpose

With this Administrative Instruction shall be regulated licenses, means and equipments, exam and keeping records for sportive – recreative fishing.

License on recreative - sportive fishing

Licenses on sportive recreative fishing shall be issued by Federation of Kosovo Sportive Fishermen under specified procedures by this Administrative Instruction after taking the compliance by the user of the right of fishing.

Article 3

(1) Licenses for the sportive recreative fishing may be given in the term of:

a. one - day and

b. one - year.

Article 4

- (1). Licenses on sportive recreative fishing are printed under criterions as specified by
- (2). Licenses on sportive recreative fishing shall be divided in annual and daily license.
- (3). License on sportive recreative fishing is composed by two pages, with dimensions
- (4). Licenses on sportive recreative fishing shall be given under categories of fishermen.
- (5). Licenses on sportive recreative fishing must be printed in Albanian language, Serbian and English language,
- (6). Annual licenses on sportive recreative fishing must be plasticized.

Article 5

- (1). In forms of all certain licenses by this Administrative Instruction in first page from the beginning should content the following text:
- a. Federation logo
- b. name of body that give the license,
- c. designation of license,
- d. following calendar year and the term of license,
- e. serial number of license,
- f. category of fishermen.

Article 6

- (1). Back coverage of daily license content:
 - a. name and surname of fishing,
 - b.dwelling (country, place, street and number of flat),
 - c. number of the identification document,
 - d. region of fishing,
 - e. signature of the authorized person.

- (1). Back part of the annual licenses must content:
 - a. name and surname of fisherman,
 - b. residence (country, place road and no. of the flat),
 - c. number of the identification document,
 - d. fishing region,
 - e. stamp on user right of the fishing and signature of the authorized person,
 - f. stamp and signature on the authorized person of Federation.

Article 8

- (1). Daily license is valuable 24 hour since the issuance hour.
- (2). Annual license is valuable from of the date 01.01 up to of the date 31.12. of the following year.

Article 9

- (1). Daily and annual licenses on the sportive recreative fishing are divided in these categories:
 - a. Daily and annual license for the category of pioneers of the age up to 14 years.
 - b. Daily and annual licenses for the category of juniors Kosovo citizens and foreign citizens of the age from 15 - 18 years.
 - c. Daily and annual license for the category of Kosovo citizen's seniors and foreign citizens with the age above 18 years.
 - d. Daily and annual license for the category of Kosovo citizen pensioners and foreign one of the age above 65 years.

Article 10

- (1). Height of the compensation for the daily and annual license of the fishing of Kosovo citizens and foreign are determined by the user of the right of fishing under management program.
- (2). Height of the compensation for licenses of fishing for foreign citizen must be at least twofold of the licenses for Kosovo citizens.

Article 11

(1). User of fishing right determines the prices of (daily and annual) licenses just to the fishermen with certificate for the passing of examination for the fishermen through Federation of Sportive Fishermen of Kosovo.

(2). User of fishing right is obliged to inform the fisherman for limits of region or area of fishing for which has gained the right of management, as well as means and equipments with what may fish.

Article 12

- (1). Federation of Kosovo Sportive Fishermen is obliged to keep the register of issued licenses.
- (2). Federation of Sportive Fishermen of Kosovo is obliged to inform the Ministry for the number of registered fishermen.
- (3). Federation of Kosovo Sportive Fishermen is obliged to compile the manual (for given of examination) for the candidates of fisherman.
- (4). Form and content of licenses on fishing are presented in annex 1 of this Administrative Instruction.

Article 13

Means and equipments on the recreative - sportive fishing

- (1). Sportive recreative fishing may be by the mostly of three sticks for fishing by one fishing rod.
- (2). Excluding from the paragraph 1 of this article may fish with two fishing rod, if they are used as artificial alluring.
- (3). Fishing of types of trout's may be done just by one stick for fishing with one artificial alluring.

Article 14

- (1). It is prohibited the fishing with fish (alive or dead) as alluring.
- (2). It is prohibited a sportive recreative fishing using the alive natural alluring and dead one such as (earthworm, locust etc) in waters where are circulated fish of trout fish excluding other types of fish.
- (3). It is prohibited the alluring of fish with food with the purpose of gathering of fish in place of fishing.
- (4). It is prohibited the use of light for fishing.

Article 15

- (1). During the sportive recreative fishing may be used the following equipments:
 - a. networks for catching fish out of fish during the recreative sportive of fishing,
 - b. network for reserve of fish,
 - c. fishing rod for draw away of hunting.

Registration of hunting through fishing

- (1). Fisherman is obliged that after windup of the fishing and removal by waters of fishing to indicate data for quantity and type of fish in the register of hunting registration.
- (2). Data from the recreative sportive fishing registered in the register the fisherman is obliged to send the right of fishing at latest on 5th of the following month for the preliminary month for being registered in the annual register.
- (3). User is obliged to put data register on recreative sportive fishing (quantity and type) at Federation's disposal up to the date 10 of the following month for the preliminary month.
- (4). Federation is obliged to put data register on recreative sportive fishing (quantity and type) at Ministry's disposal up to 31 January for the following month of the preliminary month.
- (5). Content of the register is presented in annex 4 of this Administrative Instruction.
- (6). Registers on registration of hunting are printed and spread by the Federation of Sportive Fishermen of Kosovo (FSFK).

Article 17

Examination on recreative - sportive fishermen

- (1). Any fisherman must pass the exam for fishing.
- (2). According to the program approved by Ministry the examination shall be organized and implemented by Federation.
- (3). Program for the exam is made up by the following field:
 - a. legislation for recreative sportive fishing,
 - b. type of fish in waters of Kosovo,
 - c. protection of fish,
 - d. activity with fish,
 - e. rules of fishing.
- (4). Fields from paragraph 3 of this article shall be used for the formulation of questions for candidates.
- (5). Examination for fisherman may be organized in written or in oral.

Article 18

- (1). Commission to the assessment of candidates for fishermen shall be appointed by Ministry with the proposal of Federation.
- (2). Commission is made up of minimum of 3-5 professional members.
- (3). Payment for the examination of fisherman is 10 € for 1 (one) candidate.
- (4). Determined value for the examination shall be paid on the federation account.

- (5). Federation is obligated to cover all the costs for the organization and implementation of the examination.
- (6). Members of commission have the right on wages on the height of average of a wage in country
- (7). For progress of examinations, the secretary of federation keeps the minutes of meetings for candidates.
- (8). Candidate is evaluated with passed or failed.
- (9). For those having passed the exam, federation issues a certification according to a form presented in annex 3 of this administrative instruction.

- (1). Federation keeps the register of candidates that passed the exam.
- (2). Register of candidates includes the following data:
 - a. ordinal number of register
 - b. series number of issued certificate
 - c. candidate data (name and surname, address, ID no, place of birth and state).
 - d. examination data (place and date of passing the exam, the authorized person).

Article 20

Control and inspection

Physical and legal persons which deal with recreative-sport fishing are obligated at any time to show to the authorized inspector the required documentation and to enable free access in any quantity of recreative-sport fishing.

Article 21

Sanctions

Non-implementation of this Administrative Instruction shall be sanctioned according to article 61 paragraph 1 point a) of Law on fishing and aquaculture.

Article 22

Annexes 1, 2, 3 and 4 presents component parts of this Administrative Instruction.

Article 23

This Administrative Instruction will enter into force upon its signature day.
